

2020-2021 FREE & REDUCED MEAL INFORMATION & SCHOOL FEE WAIVER INFORMATION



At Maplewood Career Center the cafeteria's mission is to serve the best meals our students will have that day. **Breakfast cost: \$1.75. Lunch cost: \$3.00.**

Your children may qualify for free meals or for reduced price meals. **Reduced prices are \$.30 for breakfast and \$.40 for lunch.**

Please review the following carefully. Students who qualify for free meals may also qualify for a fee waiver. A NEW APPLICATION MUST BE APPROVED FOR THE 2020-2021 SCHOOL YEAR TO RECEIVE FREE OR REDUCED MEALS AND/OR THE WAIVER. (Reduced status does NOT qualify for Fee Waiver.) There are two methods for qualifications:

1. DIRECT CERTIFICATION

- If you received a letter stating your student is ELIGIBLE FOR DIRECT CERTIFICATION, YOU DO NOT need to fill out an application for free and reduced meals. Your student is automatically eligible for free meals. (Letters are mailed 2nd week of August 2020). To receive student fee waiver, you MUST SIGN AND RETURN the waiver portion of the Direct Certification notification.
- All children living in the household with a student who qualifies under Direct Certification are also eligible for free meals and fee waiver. 2. APPLICATION PROCESS

- Free and reduced applications are part of this summer mailing package.
- A new application must be submitted/approved for the 2020-2021 school year to receive free or reduce meals. This is both for INCOMING JUNIORS and RETURNING SENIORS.
- **INCOMING JUNIORS** – Please bring in your application on the evening of orientation **AUGUST 25, 2020**. Please hand-in to the Food Service Director. **Note:** Juniors coming from CEP schools have 10 operating days to reapply from the start of the school year, August 31, 2020.
- **RETURNING SENIORS** – Please return your application during the first week of school or sooner. Please hand-in to the Food Service Director.

Important – please read carefully



Maplewood Career Center Food Service use a computerized Point of Sale system for the purchase of school meals. Students will use a 4-digit PIN (last 4 numbers in their social security number) to access their accounts to purchase meals. The system is confidential, and all students will be required to enter their PIN regardless of meal status or payment method, thus ensuring student privacy. Once the PIN is entered the student's picture appears on the register screen for the cashier to verify the student. If at any time student forgets their PIN the cashier can obtain it at the register.

You are not required to make advance payments to your student's account because the system can accept cash payments daily. However, for your convenience, you may choose one of the payment options for making advance payments. Money will only be deducted from account when the student uses the account to purchase meals & or ala carte items. The system will know the meal status of the student (full pay, free or reduce) and will only deduct the correct amount from the account.

PAYMENT OPTIONS

➤ Option 1: Cash on Account

Payment is made in form of cash or check (made to Maplewood Career Center).

These funds are deposited directly into the student's account and then available for purchases

➤ Option 2: EZ Pay On-line Payment

This is a secure online payment system. The link is on the Maplewood web site under High School/Parent tab. Parents can deposit money onto accounts. EZ Pay does charge a small fee and please allow 24 hours for funds to transfer to student accounts.

There is no limit on the amount of money that can be deposited into the account. Balances will carry over to the next school year for juniors. Senior students should monitor their accounts to have an ending balance of \$0 at the end of the school year. On occasions that a student does not have adequate funds for a meal; an alternate meal will be provided at the nurse's station.

If your family has financial hardship or change of income, you may qualify for Free or Reduced Meal Program. A new application must be completed each school year. Applications are available in Student Services Office or print the application from the Maplewood web site. Free & Reduced meals include breakfast and lunch. **(Breakfast is served daily from 7:45 am – 8:10 am.)** Menus are posted in classrooms, dining area and are available at the Maplewood web site: <https://www.mwood.cc/hs/food-service/>

Frequently Asked Questions About Free and Reduced-Price School Meals

Dear Parent/Guardian:

Children need healthy meals to learn. Maplewood Career Center offers healthy meals each school day. Breakfast costs **\$1.75** and lunch costs **\$3.00**. **Your children may qualify for free meals or for reduced-price meals.** Reduced price is **\$.30** for breakfast and **\$.40** for lunch. This packet includes an application for free or reduced-price meal benefits and detailed instructions. Below are some common questions and answers to help you with the application process.

1. **Who can receive free or reduced-price meals?** All children in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP) or Ohio Works First (OWF); foster children that are under the legal responsibility of a foster care agency or court; children participating in their school's Head Start program; and children who meet the definition of homeless, runaway, or migrant are eligible for free meals. Also, your children may receive free or reduced-price meals if your household's income is within the federal income eligibility guidelines limits.

2. **How do I know if my children qualify as homeless, migrant or runaway?** If members of your household lack a permanent address; are staying together in a shelter, hotel or other temporary housing arrangement; relocate on a seasonal basis or; children live with you who have chosen to leave their prior family or household then the children may qualify as homeless, migrant or runaway. If you have not been told your children will receive free meals, please call **330-296-2892** or email **hintonjo@mwood.cc** to see if they qualify.
3. **Do I need to fill out an application for each child?** No. Use one free and reduced-price school meal application for all students in your household. We cannot approve an application that is not complete. Please submit all required information. **Return the completed application to: Food Service Director, Maplewood Career Center, 7075 State Route 88, Ravenna, OH, (330) 296-2892 ext. 551503.**
4. **Should I complete an application if I received a letter this school year saying my children are approved already for free meals?** No, but please read the letter carefully and follow the instructions. If any children in your household were missing from the eligibility notification, contact **Joe Hinton, Food Service Director, Maplewood Career Center, 7075 State Route 88, Ravenna, OH, (330) 296-2892 ext. 551503.**
5. **Can I apply online?** NO! However, you can print out the application at the Maplewood web site. Visit: **<https://www.mwood.cc/hs/food-service/>**
6. **My child's application was approved last year. Do I need to complete another application?** **Yes.** Your child's application is valid for that school year and for the start of this school year. You are required to submit a new application unless the school notified you that your child is eligible for the new school year.
7. **I receive Women, Infants and Children (WIC) benefits. Can my child(ren) get free meals?** Children in households participating in WIC may be eligible for free or reduced-price meals. Please submit a completed application.
8. **Will the information I give be checked?** Yes, we also may ask you to send written proof.

9. **If I do not qualify now, may I apply later?** Yes. You may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free and reduced-price meals if the household income drops below the income limit.
10. **What if I disagree with the school's decision about my application?** You should talk to school officials. You also may ask for a hearing by calling or writing to the following contact person: **Business Affairs, Maplewood Career Center, 7075 State Route 88, Ravenna, OH, (330) 296-2892.**
11. **May I apply if someone else in my household is not a U.S. citizen?** Yes. You or your child(ren) do not have to be a U.S. citizen to qualify for free or reduced-price meals.
12. **What if my income is not always the same?** List the amount that you normally receive. For example, if you normally make \$1,000 each month, but you missed some work last month and only made \$900, submit the report with the routine amount of \$1,000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.
13. **What if some household members have no income to report?** Household members may not receive some types of income that are asked for you to report on the application or may not receive income at all. When this happens, please write a 0 in the corresponding field. However, if any income fields are left empty or blank, those also will be counted as zeroes. Please be careful when leaving income fields blank.
14. **We are in the military. Do we report our income differently?** Your basic pay and cash bonuses must be reported as income. If you get any cash value allowances for off-base housing, food, or clothing, it also must be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any additional combat pay resulting from deployment also is excluded from income.
15. **What if there is not enough space on the application for my family?** List any additional household members on a separate piece of paper and attach it to your application. Contact **Maplewood Career Center at (330) 296-2892 to receive a second application.**
16. **Why am I being asked to give my consent for an instructional fee waiver?** Ohio public schools are required to waive the school instructional fees for children that qualify for free meal benefits. School food service personnel must have parent consent to share the student meal application if your child(ren) qualify for a fee waiver. If you agree to allow your child(ren)'s meal application to be shared with school officials to see if they qualify for a fee waiver then select **yes** in part 5. If you do not wish for that information to be shared, then select **no** in part 5. Answering no to this question will mean your child will not be considered for a fee waiver. Answering this question either way will not change your child(ren)'s free or reduced-price meal eligibility.
17. **My family needs more help. Are there other programs we might apply for?** To find out how to apply for Ohio SNAP or other assistance benefits, contact your local assistance office or call 877-852-0010.

You are not required to provide information, but if information is not provided, the state agency cannot approve your child for free or reduced-price meals. You must include the last four digits of the social security number of the adult household member who signs the application. The last four digits of the social security number is not required when you apply on behalf of a foster child or you list a Supplemental Nutrition Assistance Program (SNAP), Ohio Works First (OWF) case number or other identifier for your child or when you indicate that the adult household member signing the application does not have a social security number. We will use your information to determine if your child is eligible for free or reduced-price meals, and for administration and enforcement of the lunch and breakfast programs. We may share your eligibility information with education, health, and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.

Persons with disabilities who require alternative means of communication for program information (e.g. Braille, large print, audiotape, American Sign Language, etc.), should contact the Agency (State or local) where they applied for benefits. Individuals who are deaf, hard of hearing or have speech disabilities may contact USDA through the Federal Relay Service at (800) 877-8339. Additionally, program information may be made available in languages other than English.

SHARING INFORMATION WITH MEDICAID/Healthy Start, Healthy Families

Dear Parent/Guardian:

If your children receive free or reduced-price school meals, they may also be able to get free or low-cost health insurance through Medicaid or the State of Ohio Healthy Start, Healthy Families Program. Children with health insurance are more likely to get regular health care and are less likely to miss school because of sickness.

Because health insurance is so important to children's well-being, **the law allows us to tell Medicaid and Healthy Start, Healthy Families that your children are eligible for free or reduced-price meals, unless you tell us not to.** Medicaid and Healthy Start, Healthy Families only use the information to identify children who may be eligible for their programs. Program officials may contact you to offer to enroll your children. Filling out the Free and Reduced-Price School Meals Application does not automatically enroll your children in health insurance.
